Use/Description of Product: Mini Granular Fertilizer for use on Amenity Turf Areas.

2. COMPOSITION/INFORMATION ON INGREDIENTS:

This organic based fertilizer contains the following materials:

Ingredient Names:

- vinasse extract
- bone meal
- chicken litter
- meal of oil press-cake derived from cheanut
- feather meal
- blood meal

Contains animal proteins. Do not use on pastures

3. HAZARDS IDENTIFICATION:

Non hazardous

4. FIRST AID MEASURES (SYMPTOMS):

Ingestion: Accidental or deliberate ingestion is unlikely to cause significant toxicity.

Eye Contact: Irrigate thoroughly with water and if discomfort persists, obtain medical attention.

Skin Contact: If irritation occurs wash skin thoroughly with water.

Inhalation: Remove patient from source of exposure. If asthmatic seek medical advice.

5. FIRE FIGHTING MEASURES:

Extinguishing Media: In a fire situation use water, carbon dioxide or foam.

7. HANDLING & STORAGE:

Storage conditions: Shelf life at least 24 months. Packaging material is printed polyethylene. Keep Dry. Do not store near herbicides

Handling: not dangerous if proper industrial standards are applied.

Appearance: Minigran = micro-granule with measurements between 800 and 2.500 micron of which min. 80% between 1.000 and 2.000 micron

Properties: Decomposable organic vegetable and animal residues sterilised according to EU requirements and mixed with some inorganic products.
Insoluble in water, but will absorb small amounts of water in/on the soil where it can be decomposed by soil micro-organisms.

Chemical Stability: Stable under normal ambient conditions.
