### 4. FIRST AID MEASURES:

**Skin Contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.

**Eye Contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.
